Whereas, a Tentative Seniority List of Orderlies/ Safaiwala/ Library Attendant working in the pay level SL-1 (14800-47100) of District Cadre Rajouri was circulated vide this office No: Agri/DAJ/Estt-75/Seniority/2018-19/219-20 dated: 08.04.2019 for follow up the action as under:

1. The seniority list may be displayed at prominent place on the Notice Board and shown to each of the officials working in their scheme/ office/ district to make them aware of their seniority position;
2. The concerned officials may file their objections, if any, in respect of their seniority with authenticated proof/supporting documents within a period of 30 days from the date of issue;
3. The aggrieved employee may submit his/her representation through his/her controlling officer with an advance copy to this Directorate;
4. All representations received from the officials regarding discrepancies may be forwarded to this Directorate by the Controlling Officer with his comments clearly supporting or contradicting the claims;
5. Date of birth as has been recorded in the seniority list will not be taken as authenticated unless it is properly supported by a proof of authentication in this regard;
6. The copy of the seniority list duly signed by each of the officials who have no objection to it be furnished to this Directorate; and
7. The objections received after stipulated date shall not be considered

Whereas, it has been observed that Shri Mohd Iqbal appearing at S. No. 5 has since been expired on 08.11.2007 and the benefit of SRO-43 has already been extended in favour of his wife;

Whereas, Shri Aftab Hussain appearing at S. No. 13 in the said Seniority list has raised objection for deletion of his name from the Seniority list of Orderlies and inclusion of his name in the Seniority List of Malies of Rajouri District on the grounds that he was appointed on the post of Class-IV by the Deputy Commissioner, Rajouri but was adjusted for drawal of salary on the post of Orderly in the office of the ASCO Rajouri;

Whereas, another candidate namely Miss Ritu Bala was appointed on the post of Orderly by the Director of Agriculture, Jammu against which post Shri Aftab Hussain was adjusted for pay purpose;


Whereas, the order of the Director Agriculture, Jammu was implemented;
