

Whereas, Shri Jaffer Ali Genu has filed the Writ Petition bearing WP ( C) No. 3844/2019 which was disposed off on 17.10.2019 with the direction to the respondents to consider the claim as projected by the petitioners in the writ petition strictly under rules permissible to the field and having regard judgment/ order dated: 14.11.2017 passed in SWP No. 315/2004 if the same is applicable to the case in hand.
