

Terms and conditions

Annexure – B, Providing Vehicles Sumo / Tata Indica and any other light motor vehicle along with driver

1. Particular of vehicle:-
2. Valid registration for use commercial purpose/Taxes/permission on such vehicle shall be liability of contractor.
3. Service provider having minimum three year experience, supported by authentic documents.
4. Rates Quoted should be inclusive of cost of fuel, driver Charges, other charges like insurance / repair/ maintenance etc.
5. Services of the vehicle and driver will be on complete disposal of the department from 09.00 A.M. to 05.00 P.M. on all days . In case of emergency driver can be retained for 24 hrs, no over time shall be allow except over night charges.
6. Payment shall be made on monthly basis inclusive of all taxes etc. i.e. 10th of each month
7. Driver must wear uniform whenever it is required by the department.
8. Approved Contractor /service provider will not sublet the contract to any other contractor.
9. In the event of any mechanical failure/break down of vehicle during duty/after duty the contractor will make alternate arrangement by replacing with other Commercial Vehicle. Non Compliance may interact penalty.



10. In case of accident, resulting in loss or damage to property or life the sole responsibility for any legal or financial implication would vest with the contractor, the department shall have no liability whatsoever.
11. Any driver once removed on complaint of the department will not be employed in the department by contractor.
12. Vehicle and driver should be eligible / willing to travel within and outside state whenever it is required by the department.
13. In case maintenance or repair of vehicle are not carried out timely the department shall be at liberty to carry out required repair and deduct the amount from hire charges.
14. Validity of agreement shall be for 1 Year (12 months) from the date of execution of agreement. In case the services of the contractor / service provider found satisfactory the period of contract may be considered for further extension.
15. Any legal dispute/claims arising out during currency of agreement in respect of Vehicle, provided by contractor the department will not be liable for any loss, damages, suffering of contractor etc.
16. Any traffic violations and other criminal offences arise out of in respect of driver or vehicle during agreement period department shall not be liable.
17. In case the condition of vehicle provided by contractor is not as per satisfaction of the department the same will be replaced / substituted as per demand. Failing which department shall be at liberty to arrange vehicle from open market, the expenditure on that account shall be borne by the contractor.
18. The successful tenderer shall have to enter into an agreement on prescribed performa on non judicial stamp paper of Rs.20/- with the indenting officer before job order is issued in his favour for effecting supplies.
19. In case of dispute the decision of Director of Agriculture Jammu shall be final.
20. Legal proceedings, if any, are subject to the jurisdiction of the courts located in Municipal limit of Jammu (J&K State)

Annexure-B, Placement of drivers for applying on Department Vehicles

Annexure – A, Placement of drivers :-Driver having valid license for commercial driving, having minimum five year experience, supported by authentic documents for plying on Department Vehicles


- (a) Services of the driver will be at complete disposal of the department from 09.00 A.M. to 05.00 P.M. on all days . In case of emergency driver can be retained for 24 hrs, no over time shall be allowed except over night charges to be quoted.
- (b) Any driver once removed on complaint of the department will not be employed in the department by placement agency.
- (c) Driver should be eligible / willing to travel within and outside state whenever it is required by the department.
- (d) Validity of agreement shall be for 1 Year (12 months) from the date of execution of agreement. In case the services of the contractor / service provider found satisfactory the period of contract may be considered for further extension.
- (e) Holding Valid driving License by driver for use commercial purpose having minimum five year experience, supported by authentic documents.
- (f) Payment shall be made on monthly basis inclusive of all taxes etc. i.e. 10th of each month
- (g) Driver must wear uniform whenever it is required by the department.



- (h) Approved Contractor /service.provider will not sublet the contract to any other contractor.
- (i) Any traffic violations and other criminal offences arising out of in respect of driver during agreement period department shall not be liable.
- (j) The successful tenderer shall have to enter into an agreement on prescribed performa on non judicial stamp paper of Rs.20/- with the indenting officer before job order is issued.
- (k) In case of dispute the decision of Director of Agriculture Jammu shall be final.
- (l) Legal proceedings, if any, are subject to the jurisdiction of the courts located in Municipal limit of Jammu (J&K State)
