Sanction is hereby accorded to the temporary appointment of Shri. Tarun Sharma S/o Late Shri Rajesh Kumar (Ex. Field Assistant) R/o H.No. 180, Sector 04, Sharkia Vihar Lower Roop Nagar Tehsil & District Jammu **as Class IV (Orderly)** in the Pay Level SL-1 (14,800-47,100) in Agriculture Production and Farmer's Welfare Department under SRO-43 of 1994 in District Cadre Jammu against available vacancy in the office of Sub Divisional Agriculture Officer, Marh.

The appointee shall report to the Chief Agriculture Officer, Jammu within a period of 21 days from the date of issuance of this order, If the candidate fails to Join within the stipulated time, he shall forego his right to appointment, and the same shall be deemed to have cancelled ab-initio without any further Notice.

The appointee shall be allowed to join only on the production of following certificates/documents (in original) to be verified subsequently:

- 1) Academic Qualification Certificates
- 2) Date of Birth Certificate
- 3) Domicile Certificate
- 4) Health Certificate issued from the concerned Chief Medical Officer of the District
- 5) Dependent Certificate issued by the Competent Authority
- 6) No Loan Certificate under Self Employment Scheme from the District Industries Centre (DIC) and District Employment & Counselling Centre
- 7) Any other relevant document as required under SRO-43 of 1994

The appointment of the above candidates shall be subject to the following conditions that:-

- a) the appointee shall give an undertaking in the shape of affidavit to the effect that if, on verification, genuineness of the certificate(s) produced by the appointee is proved to be fake / forged, the claim of the appointee for appointment as Class-IV (Orderly) shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
- b) the appointee(s) shall give an undertaking that in the event of any adverse report received from CID, subsequently, the appointment of the appointee (s) shall be deemed to have been cancelled ab-initio.
- c) The appointee(s) shall be on probation for a period of two years.
- d) The appointment of above candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- e) The appointment of the above appointee shall be subject to the outcome of any writ petition(s) if any, pending before any court of competent Court of Law.
