- b) The appointee(s) shall be on probation for a period of two years.
- c) The inter-se-seniority of the appointee shall be determined as per the J&K Civil Service (Classification, Control & Appeal) Rules, 1956.



d) That, if the candidate has taken loan for self-employment from DIC/ Employment department, to be ascertained from the District Industries Centre (DIC) and District Employement & Counselling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment unit/enterprise before joing the Government Service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerened shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
