Consequent upon the cancellation of candidature of Sh. Ravinder Singh S/o Sh. Jameet Singh R/o VPO Treru, Tehsil Teryath District Rajouri under RBA category District Cadre Rajouri vide Directorate of Agriculture Jammu's Order No. 128-DAJ of 2023 dated 17.04.2023, sanction is hereby accorded to the temporary appointment of Mr.Shakeel Ahmed S/o Mohd. Ramzan Wani R/o 03 Village khunoo Panchayat Bagla, Block Dali Udhyampur Tehsil Bharath Bagla District Doda as Plant Protection Operator in the office of Sub Divisional Agriculture Officer, Darhal in the Pay Level -2 (19900-63200) District Cadre Rajouri.

The appointee shall report to the Chief Agriculture Officer, Rajouri within a period of twenty one (21) days from the date of issuance of this order failing which he shall forego his right to appointment and the same shall be deemed to have been cancelled ab-initio without any further Notice.

The appointee shall be allowed to join only on the production of following certificates/documents (in original) to be verified subsequently:

1. Academic/Qualification Certificates.
2. Matriculation / Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District
4. Domicile Certificate issued by the Competent Authority.
5. Valid relevant Category Certificate, if any, applicable

The appointment of the above candidate shall further be subject to the following conditions that:-

- a) The appointee shall give an undertaking in the shape of affidavit to the effect that if, on verification, genuineness of the certificate(s) produced by the appointee is proved to be fake or forged, his appointment shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
- b) That, if the candidate has taken loan for self-employment from DIC/ Employment department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment Unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- c) The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification / Date of Birth / Relevant Category Certificate is received from the concerned Authorities / Agency.
- d) The appointee shall be on probation for a period of two years.
- e) The appointment of above candidate shall be governed by the **"New Pension Scheme"** as per SRO 400 of 2009 dated 24.12.2009.
- f) The inter-se-seniority of the appointee shall be determined as per the J&K Civil Service (Classification, Control & Appeal) Rules, 1956.
- g) The appointment of the above appointee shall be subject to the outcome of any writ petition(s) if any, pending before any court of competent Court of Law.
