
Whereas, the final selection list of the candidates for the posts of Plant Protection Operator, (Item Nos. 266, 267, 268, 269, 270, 271 & 272, Farm Supervisor & Beekeeper, (Item Nos. 273, 274, 275), Field Supervisor, (Item No. 276 & 277), Bee Keeper / Field Assistant Grade III/ Equivalent, (Item nos. 279, 280, 281, 282, 283, 284, 285, 286, 287, 288, 289, & 290) in Department of Agriculture Production & Farmer's Welfare Jammu was issued by J&K Service Selection Board vide No. SSB/Secy/Sel/2022/6308-18 dated 21.10.2022 and further endorsed to this Directorate by Administrative Department vide No. Agri/Coord/06/2021 dated 29.10.2022;

Whereas, following two candidates who were selected as Plant Protection Operator in selection list issued by JKSSB have not reported for e-verification / joining till date. Their applications regarding unwillingness to join Agriculture Department have been received by this Directorate and forwarded to Administrative Department vide letter No. Agri/DAJ/Estt-172/2022-23/8502 dated 04.02.2023;

**Whereas, the Administrative Department vide No. Agri-Cord/6/2021 (CC 7091749) dated 23.02.2023 has directed to operate the waiting list strictly against the available slots where the selected candidate failed to join within a stipulated time. But before this exercise is initiated, it was advised to withdraw the appointment order of the candidate ab-initio by way of a speaking order;**
