In pursuance to Government Order No.199-JK (GAD) of 2025 Dated 08.05.2025 issued by Administrative Department, Mrs Tajally Wd/o Late Sh. Ishrat Hussain Rathore, Ex-AEA R/o House No. 10 Ward No. 06 Near Jamia Masjid Kishtwar, who has been temporarily appointed as **Orderly/MTS** in the Pay Level SL-I (14800-47100) District Cadre, Doda in Agriculture Production and Farmers Welfare Department, Jammu under clause 3 (a) of the Jammu and Kashmir Rehabilitation Assistance Scheme, 2022 (RAS) read with S.O 397 of 2024 dated 16.08.2024 and **has joined this Directorate on 13.05.2025**, is hereby further adjusted as MTS against the available vacancy under the control of Chief Agriculture Officer, Doda.

The appointee shall report to the **Chief Agriculture Officer, Doda** alongwith the following original certificates / documents to be verified subsequently for further duties:

1. Academic Qualification Certificate.
2. Date of Birth Certificate
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Domicile Certificate
5. All other relevant documents as required under Jammu and Kashmir Rehabilitation Assistance Scheme, 2022.

**The appointment of above-mentioned candidate shall be subject to the following conditions that:-**


- a. That she shall give an undertaking in the shape of an Affidavit to the effect that if on verification, her Qualification/Date of Birth/Category Certificates if any, from the concerned issuing authority are found to be fake/forged, the claim of the appointee for appointment as Class-IV (MTS) shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against her.
- b. That she shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate First Class, to the effect that the applicant is unemployed as on date and none of the family members other than the applicant has taken benefit of compassionate appointment under SRO-43. In case it turns out that the applicant is already appointed or the benefit of compassionate appointment under SRO-43 of 1994 has already been extended to the family of the deceased, then the instant appointment shall be deemed to have been withdrawn ab-initio without any further notice.
- c. That she shall give an undertaking in the shape of an Affidavit to the effect that she shall maintain properly the other family members who were dependent on the

deceased and in case it is proved at any time that the dependent family members are being neglected or not being properly maintained by her, her appointment shall be terminated.

- d. That If the candidate has taken loan for self-employment from DIC/ Employment department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the Domicile District, she shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment Unit/enterprise before joining the Government Service. She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self- employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- e. The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of genuineness of Qualification/Date of Birth/Category Certificate, if any, is received from the concerned Authorities.
- f. That the appointee shall be on probation for a period of two years.
- g. The appointment of the candidate shall be governed by the **"New Pension Scheme"** as per SRO 400 of 2009 dated 24.12.2009.
- h. The appointment of the above appointee shall be subject to the outcome of any writ petition(s) if any, pending before any court of competent Court of Law.
