Subject:- Acceptance of resignation of Mr. Vijay Bharat (Khalasi) Apiculture Development Scheme, Doda.

Whereas, on the recommendation of Service Selection Board, J&K, the Administrative Department vide Government order No. 173-JK (Agri) of 2021 dated 22.10.2021 had appointed Mr. Vijay Bharat S/o Sh. Ram Lal R/o Shaleen (Kotli) Tehsil Kastigarh District Doda as Class-IV in AP&FW Department under District Cadre Doda among others and accordingly the incumbent joined the Agriculture Department on 29.10.2021 and was directed to report to the Chief Agriculture Officer, Doda vide this Directorate's order No. 258-DAJ of 2021 dated 27.11.2021.

Further, vide this Directorate's order No. 262-DAJ of 2021 dated 01.12.2021 issued under endorsement No. Agri/DAJ/Estt-01/2021-22/4852-61 dated 01.12.2021; Mr. Vijay Bharat appointee was adjusted as "**Khalasi**"(Class-IV) in Apiculture Development Scheme Doda.

Whereas, subsequent to his appointment, the Chief Agriculture Officer, Doda vide No. Estt-/2022-23/1615-16 dated 06.09.2022 reported that Mr. Vijay Bharat (Khalasi), is not interesting to serve on said post and tendered his written resignation on 03.09.2022 to the Apiculture Development Officer, Doda on the grounds that he want to peruse his further studies.

Whereas, the case of the incumbent was referred to the Administrative Department vide this office letter No. Agri/DAJ/Estt/PF-10/2022-23/4679 dated 06.10.2022 for seeking approval for acceptance of resignation of applicant from the post of Khalasi as the official was still on probation at the time of tendering of his resignation and not qualified the prescribed service.

Whereas, the Administrative Department vide letter No. Agri-Cord/153/2021(CC-75746) dated 07.11.2022 has conveyed the administrative approval for acceptance of the resignation of the official w.e.f 03.09.2022.

Therefore, consequent upon the administrative approval conveyed by the Administrative department as mentioned above, the resignation tendered by Mr. Vijay Bharat S/o Sh. Ram Lal R/o Shaleen (Kotli) Tehsil Kastigarh District Doda, from the post of Khalasi (Class-IV) in district Doda is hereby accepted in terms of Rule 22 (1) (b) of J&K Civil Service (Classification, Control and Appeal) Rules, 1956 and he is discharged from the service w.e.f 03.09.2022.
