That the Drawing & Disbursing Officer shall only allow the benefit of In-Situ promotion to those persons, who had not availed the benefit of three promotions including functional promotion, if any, granted during the entire period of their services.

That the benefit of In-situ promotion shall be subject to further verification from the original record by the concerned Drawing & Disbursing Officer.
