Any false information provided by the appointee or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment without any further notice.
- b. The appointee shall furnish an Undertaking in the shape of an Affidavit as per Annexure-A to this Order:
- c. The salary of the appointee shall not be drawn and disbursed to them unless\_the\_satisfactory\_reports\_in\_respect\_of\_genuineness of Qualification/Date\_of\_Birth/Relevant Category Certificate and Final Character & Antecedents Report is received from the concerned Authorities/Agency.
- d. The appointee shall be on probation for a period of two years.
