Whereas, a Tentative Seniority List of Mail/ Gardener/ Laboratory Attendant/ Khalasi/ Mushroom Cultivator/ Plant Protection Operators/ Mali-Cum-Chowkidar/ Helper/ Watchman/ Jaribkash/ Weighman/ Guard working in Pay Level- SL-1 (14800-47100) of Ramban District Cadre falling in Class-VIII, Category A of Schedule-II (Executive) of Jammu and Kashmir Agriculture (Subordinate) Service Recruitment Rules, 2017 was circulated to the concerned controlling officers vide this office circular endorsement No: Agrir/DAJ/Estt-Seniority/2022/ 4994-96 dated: 21.10.2022 for follow up action as under:

1. The seniority list may be displayed at prominent place on the Notice Board and shown to each of the officials working in their scheme/ office/ district to make aware them of their seniority position.
2. The concerned officials may file their objections, if any, in respect of their seniority with authenticated proof/ supporting documents within a period of 21 days from the date of issue.
3. The aggrieved employee may submit his/her representation through his/her controlling officer with an advance copy to this Directorate.
4. All representations received from the officials regarding discrepancies may be forwarded to this Directorate by the controlling officers with his comments clearly supporting or contradicting the claims.
5. Date of Birth as has been recorded in the seniority list will not be taken unless it is properly supported by a proof authentication in this regard.
6. The copy of the seniority list duly signed by each of the officials who have no objection to it be furnished to this Directorate, and;
7. The objections received after the stipulated date shall not be considered.

Whereas, Shri Punjab Singh, Khalasi appointed on notional basis w.e.f.01.04.2000 vide Agriculture Order No.404/E of 2018 dated: 25.07.2018 was omitting from the seniority list which have now been incorporated on the basis of his appointment order;

Whereas, the incumbents appointed on Class-IV posts vide Govt. Order No. 175-JK (Agri.) of 2021 dated: 23.10.2021 have represented that their seniority has not been fixed according to the merit gained in the common test conducted by the J&K Service Selection Board (JKSSB);
