5. Date of Birth as has been recorded in the seniority list will not be taken unless it is properly supported by a proof authentication in this regard.
6. The copy of the seniority list duly signed by each of the officials who have no objection to it be furnished to this Directorate, and;
7. The objections received after the stipulated date shall not be considered.

Whereas, the Final Seniority list of Draftsman was issued vide this office order endorsement No: Agri/DAJ/Estt-Seniority/75/2018/2391-92 dated: 19.02.2020 for filing appeal to the competent authority if any one aggrieved with the seniority list;

Whereas, neither any objection nor any appeal has been received against the said seniority list and a revised Final Seniority list was issued vide this office No. Agri/DAJ-Estt-62/Seniority/2022/5097-98 dated: 22.10.2022;
