5. Date of Birth as has been recorded in the seniority list will not be taken unless it is properly supported by a proof authentication in this regard.
6. The copy of the seniority list duly signed by each of the officials who have no objection to it be furnished to this Directorate, and;
7. The objections received after the stipulated date shall not be considered.

Whereas, the Final Seniority list of Draftsman Grade-II was issued vide this office order endorsement No: Agril/DAJ/Estt-Seniority-75/2020/2396-2402 dated: 19.02.2020 for filing appeal to the competent authority if any one aggrieved with the seniority list;

Whereas, neither any objection nor any appeal was received against the said seniority list and a revised Final Seniority list was issued vide this office No. Agril/DAJ/Estt-62/Seniority/2022/5099-5107 dated: 22.10.2022 against which one Shri Pankaj Parasher has represented for correction of Qualification as 10+2 with 2 Years Diploma in Draftsman Civil instead of Matric with Three Years Diploma in Draftsman Civil;
