- 6. The copy of the seniority list duly signed by each of the officials who objection to it be furnished to this Directorate, and:
- 7. The objections received after the stipulated date shall not be considered.

Whereas, no any objection was received against the said seniority list within the stipulated time period;

Whereas, one Shri Parshotam Singh Electrician working in the Agriculture Complex, Talab Tillo Jammu has represented for inclusion of his name in the Seniority list and further promotion to the post of Foreman on the grounds that:

- (ii) After completion of seven years service as Daily Rated Worker he was regularized on Class-IV post of Helper w.e.f. 01.04.2001 vide Govt. Order No. 137-Agri. of 2003 dated: 19.05.2003 but continued to work as Electrician;
- (iii) Vide Agriculture Order No. 49/E of 2009 dated: 21.02.2009, he was placed in the grade of Electrician (5000-8000 old) w.e.f. 14.03.2008 on the analogy of Helpers of PHE Department in light of SRO-87 dated 27.02.1968, SRO-149 dated: 07.04.1973 and Hon'ble High Court of J&K Jammu's decision dated: 14.03.2008;

Whereas, the representation of Shri Parshotam Singh has been got examined by the Screening Committee and the committee has observed that the official has already been allowed the benefit of of the post and pay scale of Electrician since 14.03.2008 by virtue of Court Order as such recommended for inclusion of the name of the representee in the seniority list of Electrician at an appropriate place.
