Open Auction of Unserviceable office Store articles of Assistant Agrostologist Jammu and Chak Jaggar Farm will be held by the Auction Committee in the office of Farm Manager Chak Jaggar on Gajansoo Marh Road on 28.01.2017. The interested bidders are required to deposit a CDR/FDR of Rs. 3000 (Rs. Three thousand only) through their respective registered firms pledged to the Assistant Agrostologist Jammu of any scheduled bank latest by 27.01.2017 in the office of undersigned to make them eligible for participation in the auction. The details of the articles for auction are given in the annexure to this notice and the stocks can be physically inspected by interested bidders on any working day from 10.00 AM to 4 P.M in the office of Asstt. Agrostologist and Farm manager Chak Jaggar. The total articles to be auctioned are 95 in numbers with book value of Rs.54147.20 (Fifty Four thousand one hundred forty seven and twenty paisa only).

TERMS AND CONDITIONS

- 1. Only those parties would be eligible for participation in open auction who have deposited CDR of Rs 3000/- as a security money.
- 2. Each bidder will be allowed at the most only one helper to be with him on the auction day
- 3. The successful bidder shall have to deposit 50% of the total value of the articles secured by him/her in the office of undersigned through account payee cheque/bank draft (no cash shall be accepted in any case) with in three days of the announcement and acceptance of the bid and the 40% amount has to be deposited with in one week prior to issuing of release orders and the remaining balance amount is to be deposited before final lifting of articles.
- 4. Each bidder is entitled to furnish only one CDR/FDR through their respective registered firms
- 5. The auction articles shall be put on display in the auction premises i.e Farm Manager Chak Jaggar and Assistant Agrostologist Office Talab Tillo Jammu
- 6. The auction committee reserves the right to accept or reject any bid in case of unhealthy competition and change the condition/or suspend the auction process withour assigning any reason thereof.
- 7. The decision about acceptance/rejection of highest bid will be announced on the day of auction itself
- 8. The successful bidders shall have to lift the entire articles at the earliest possible but not beyond one week of auction in "as is where is" basis.
- 9. The CDR/FDR of the successful bidder will be released after complete lifting of the auctioned stocks for which he/She has secured the bid.
- 10. The quantity mentioned in the annexure is tentative and may increase or decrease.
- 11. The CDR/FDR of the unsuccessful bidders shall be releasded after 10 days of the conduct of auction procedure.
- 12 Damage if any, caused to Government property by the successful bidder or his representative during lifting of articles shall have to be compensated by him.
- 13. All taxes and other charges what so ever applicable under rules shall be charged from the successful bidder.
- 14. The articles secured by the successful bidder will be delivered to the concerned only during the working hours on all working days on sub mission of release order issued to the buyer after making the deposition as per the term appearing at S.No. 6 above in the shape of account payee cheque/bank draft.

- 15. In case the buyer intends to take delivery of articles through his representative, he should submit a letter of authority duly authorizing his representative to lift the articles on his behalf.
- 16. The buyer will not enter indirect deals/transfer or assign the contract or part thereof to any other party without written approval of the auction committee.
- 17. In event of any dispute or difference arising between auction committee and buyer the matter shall be referred to Director of Agriculture, Jammu for arbitration and whose decision shall be final and binding on both the parties.
- 18. The dispute, if any shall be subjected to the jurisdiction of the Hon"ble Courts located in the Municipal limits of Jammu city.

The Auction Committee may forfeit the EMD/SD/entire deposited amount of the bidder under following circumstances:

- i) If the security deposit (40%) is not deposited by the bidder as per clause no.6 of the terms and condition within stipulated time.
- ii) If the entire 90% of amount of the total value of the articles is not paid by the bidder as explained in clause no.6 with in mentioned time period
- iii) If the articles is not lifted by the bidder within the period stipulated in clause no.9
- iv) If any bidder is found indulged in anti department activity or any notice of the appropriate authority of state /centre has been received showing violation by the bidder in respect of statury obligations.
