A scanned copy of Tender Fee will be uploaded online during submission of the Bid.
- Uploading of Bids: Bids should be uploaded by bidders as per the enclosed format of Bill of Quantities (BOQ) and within the stipulated time frame. Bids should be supported with scanned copies of documents as referred to here above in the tender document.
- Time and date for opening of Bids (online only): Bids will be opened online in the office of Chairman Contarct Committee/ Directorate of Agriculture & FW, Jammu (J&K) on 27-05-2023 at 10 AM (Technical) and 27 -05-2023 at 4 PM (Financial) in presence of bidders who intent to participate in the opening process. Rates and important clauses quoted by all bidders will be read out in the presence of the representatives of all the bidders. This event will not be postponed due to non-presence of the representatives of all the bidders. The result of the opening of Bids will be available online for all bidders to see.
- Clarification regarding contents of the Tender Documents: Any bidder who requires clarification regarding the contents of the bidding documents must contact the Chairman Contact Committee/ Directorate of Agriculture & FW, Jammu (J&K) through email within two days from the publication of the bid in the print media. Thereafter no clarification shall not be taken care off.

- AWARD: The bidder to whom the contract shall be awarded at his highest quoted rate will have to
  execute and agreement with the department for successful completion of the contract within the
  stipulated time frame.
- SECURITY DEPOSIT: The successful bidder shall furnish the security deposit for an amount of Rs.50,000/- (Fifty Thousand only) in the shape of Current/Fixed Deposit Receipt (CDR/FDR) of a nationalized bank or Bank Guarantee from a nationalized bank pledged to Accounts Officer, Directorate of Agriculture, Talab Tillo, Jammu (J&K). Security deposit remains valid for a period of 04 months or successful completion of the contract. The Security Deposit (as Performance Security) shall be returned to the supplier after the expiry of the contract period on furnishing usual clearance/No Demand Certificate.
- ARBITRATION: In case of dispute of any nature arising while allotting the contract, the matter shall be referred to the Director Agriculture Jammu whose decision as arbitrator shall be final and binding upon the both the parties. In case the matter cannot be resolved amicably the filing of case by the contractor shall be subject to the jurisdiction of courts of the J&K.
