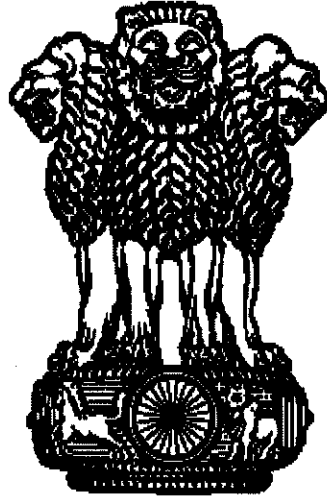

## GENERAL TERMS AND CONDITION FOR e-AUCTION

1. e-Auction document consisting of qualification information and eligibility criteria of bidders, specifications and the set of terms and conditions of the contract to be complied with by the bidder, is publicly visible in the website "<https://eauction.gov.in/>" and the intending bidder can download the documents from the website.
2. Only those parties would be eligible for participation in e-auction who are registered for sale and purchase of seed/grain stocks. A proof in this regard shall have to be produced by them to the satisfaction of the Auction Committee.
3. The participating firm/bidder who intends to participate in the bidding process shall produce & upload a copy of registration of the firm, GST number/TIN number.
4. **Earnest Money Deposit (EMD) & Auction Fee:**
  - a. **Auction Fee:**

Auction Fee of Rs. 5000/- (Rupees Five Thousand Only) in the form of Demand Draft payable to Accounts Officer, Directorate of Agriculture, Jammu is mandatory.
  - b. **EMD:**

EMD of Rs. 21,50,512.00/- (Rupees Twenty-one Lakh Fifty Thousand and Five Hundred Twelve only) i.e. 10% of the Auction start price for lot no - 01 to lot no 36 is required to be furnished by the bidder for participation in all lot of auctions. However individual lot wise auction start amount is available in Section-I of detailed NIA.
  - c. **Mode of Payment of EMD:**

CDR/FDR/Bank Guarantee.: Earnest money has to be deposited only by CDR/FDR/Bank Guarantee before Document Submission End Date in favour of **Accounts Officer, Directorate of Agriculture, Jamm.** Bidder shall have to upload the scanned copies of the EMD along with other required auction documents at <https://eauction.gov.in> before Document Submission End Date.
  - d. **Earnest money shall be released to all unsuccessful Bidders immediately after final decision about acceptance of the Highest Price Bid. However, EMD of the second highest bidders shall be released after starting the lifting by first bidder.**
  - e. The CDR/FDR of the successful bidder will be released after complete lifting of the auctioned stocks for which the bid is secured.
  - f. Prayer for converting any previous earnest money/security money, if any, to earnest money/security money for the auction under reference shall not be entertained under any circumstances.
  - g. Auction Inviting Authority may forfeit the EMD amount and Cancel the Auction, if the H1 bidder does not appear on the stipulated date & time, after being awarded the auction or in case of violation or breach of any of the terms of contract.
5. **Payment:**
  - a. The successful bidder shall have to deposit 50% of the total value of the stocks secured by him/her in the **Official account of Joint Director Agriculture (Inputs), Jammu in J&K Bank Talab Tillo, Jammu, through RTGS/NEFT in the Current Account 0321010100001103 having IFSC Code JAKAOTTALOO** only within 3 days of the finalization of the bid for issuing of Release Orders. The balance 40% amount has to be deposited within one week prior to issuing of further release orders and the remaining 10% amount is to be deposited before final lifting of material. No cash shall be accepted in any case. All release orders during the process of disposal shall be issued by the Chairman, Divisional Level Auction Committee. **Final payment maybe deposited after consultation with the Office so that no excess amount is deposited.**
  - b. If Highest (H1) bidder / bidders comply with all the norms & regulations and complete the lifting of whole assigned Lots (lots mentioned in the sale order released to a H1 bidder/ bidders) from the specified location within the scheduled time, EMD will be released.

**6. Documents to be upload**

- a. The required documents (as mentioned in Section-III Clause 6 “**List of documents to be scanned and uploaded**”) shall be submitted online on <https://eauction.gov.in> before Document Submission Last Date and **physical submission of any document after the last date and time or physical submission of bid will not be entertained & will be summarily rejected.**
- b. The interested bidder must upload/submit valid documents to participate without which no bid shall be accepted.

**7. Bid Language:**

- a. All documents to be uploaded by the Bidder shall be in English language only. In case the Bidder intends to upload a document, which is not in English but in any of the other scheduled language in the country, the Bidder shall also submit a Notarized version of the English Translation.

**8. Signing of e-auction:**

- a. Any document submitted online at <https://eauction.gov.in> should be digitally signed.
- b. Every time a new rate is to be quoted during bidding process duly digitally signed.
- c. Persons signing the auction should state in what capacity he or she is signing the auction (i.e.,) sole Proprietor, or Secretary etc., of the firm. In case of partnership firm, the auction must be signed by all the partners under proper seal of the firm. The person signing the auction form or other documents forming part of auction on behalf of another bidder shall produce a proper Power of Attorney duly executed in his favour stating that he had authority to participate in bidding and shall be bound in all matters pertaining to the contract. If the person signing subsequently fails to produce the said Power of Attorney within a reasonable time, Chairman Auction Committee, Directorate of Agriculture, Jammu may without prejudice to other civil and criminal remedies cancel the contract and hold the signatory liable for all costs and damages. The Power of Attorney should be signed by all partners in case of partnership concern and in case of firms it should be under the common seal of the company.

**9. Inspection of the Lots/ commodity:**

- a. The intending bidders before participation in auctions may conduct a physical inspection of the quality of the goods offered for sale through auction in location as mentioned in Notice Inviting Auction under “Commodity Details”. Stocks can be physically inspected by interested bidders/firms on any working day from 10:30 A.M to 4:30 P.M before participation in the auction process at Seed Processing Plant, Talab Tillo, Jammu, Divisional Seed Store, Talab Tillo, Jammu and Seed Multiplication Farm, Chinore, In case of any Doubt/Clarification regarding the auction material and other procedure the bidder can contact/seek clarification from Joint Director Agriculture (Input) Jammu/ Assistant Agriculture Engineer Seed Processing Plant, Jammu/Farm Manager SMF Chinore on tel no 9419872553, 7006015348, 7006845518. Any kind of further request of the physical inspection after due date will not be considered under any circumstances. During the inspection, selection of any material will not be allowed from the lot. Delivery of the Seed Stock will be made to the purchasers from Seed Processing Plant / Divisional Seed stores Talab Tillo, Jammu within the time limit that may be given in the Release/Delivery order on accepted auctioned rates in consultation of the Member Secretary. The lots of Seeds will be sold and delivered on “As-is Where is” basis
- b. Immediately after the Auction process is over, no complaint regarding quantity, quality, type and variety, all the other aspects of seeds etc. against any lot will not be entertained and the earnest money will be liable to be forfeited for violation of the terms and condition laid down in the auction notice in any manner.

**10. Selection of H1 Bidder:**

- a. In Multilot e-auction, each lot will be opened for bidding separately as per the scheduled Date & Time as mentioned in the Auction Notice indicating “Time Schedule and Key Details”. Bidder can also bid for each Lot separately and shall submit rate duly digitally signed.
- b. Minimum Increment Price of Rs. 5.00 per Qtls Seed & Rs. 1.00 per Bag and its multiple shall be only accepted. This is being done keeping in view the Increment Price structure followed by Food Corporation of India (FCI) while e-Auctioning Food Grains.
- c. All the participating bidders’ identities would be masked by the system in the form of randomly generated numbered ID. After the completion of the bidding process of all the Lots,

the successful masked bidder (H1) along with the rank of other masked bidders corresponding to each Lot will be visible to all the bidders on the screen of the e-auction portal.

- d. **The successful Bidder/Bidders selected through e-Auction process will be unmasked and declared by Divisional Level Auction Committee, Directorate of Agriculture, Jammu within 7 (seven) working days from the closure of bidding through issuing Award of Auction (AOA) contract online from e-Auction portal <https://eauction.gov.in>. However, efforts will be made to declare the successful bidder as early as possible, after the Forward e-Auction is over.**

**11. No Bid on a Lot:**

- a. If the bidding of a Lot/ Lots ends with a zero bid, then Divisional Level Auction Committee, Directorate of Agriculture, Jammu reserves the right to take any necessary decision (such as Cancel the Auction/ Re-auction/ Proceed without zero bid Lot etc.) without serving any prior notice and the decision taken by the Chairman will be final.
- b. In case of single bid on a lot(s), Divisional Level Auction Committee of Directorate of Agriculture, Jammu reserves the right to take any necessary decision.

**12. Actual Quantity at time of lifting:**

- a. The auction of the lots of Seeds is on 'As is where is' basis. However, the quantities mentioned in the DNIA, Section-I are tentative and may change at the time of lifting. In order to avoid any ambiguity, it is cleared that the H1 Awardee of Auction will pay for the actual quantity of lot lifted according to per unit rate worked out on final H1 accepted bid.

**13. Liability of the Department after successful auction/ delivery:**

- a. After successful auction/lifting of materials from the designated premises, Directorate of Agriculture & Farmers Welfare, Talab Tillo, Jammu shall not entertain any complaint about the quality & quantity of Lots/ commodity.
- b. Auction is on **"As-is Where is"** basis. Therefore, no complaints regarding quantity, quality, variety and packaging, bags etc. against any of the Lots, will be entertained.

**14. Quoting the rate**

**15. Acceptance of Rates:**

Quintal per day which the purchaser will have to pay failing which EMD would not be released. Also, after expiry of time as stipulated in delivery order, the risks of the sold-out materials lying in locations indicated above will lie with the purchaser.

- c. No transport, lifting and storage etc. facilities will be provided to the successful bidder from Agriculture Department.
- d. Directorate of Agriculture, Jammu shall not be liable for any claim of any damage or poor quality after the auction process is over.
- e. **However, the Auction Committee reserves the right to exempt the Godown rent/ Penalty, if any for delayed lifting of supplies, if any due to unforeseen circumstances or otherwise after proper satisfaction of the Committee.**

**17. Terms of payment**

- c. FDA shall be deposited in the Official account of Joint Director Agriculture (Inputs), Jammu in J&K Bank Talab Tillo, Jammu, through RTGS/NEFT in the Current Account 0321010100001103 having IFSC Code JAKAOTTALOO. Any other mode of payment shall not be accepted under any circumstances.

**18. No Show of the Winning (H1) Bidder/ Bidders**

- a. In case the selected Highest (H1) bidder/ bidders does not / appear in front of the Chairman, Auction Committee, Directorate of Agriculture & Farmers Welfare, Jammu after awarding the auction to sign the Agreement, then the EMD shall be forfeited and other actions may be initiated including blacklisting the Bidder and re-auction of the goods at the cost of the defaulter, after obtaining legal advice.
- b. In case the selected Highest (H1) bidder/ bidders does not show interest in lifting the goods after signing the Agreement, the EMD should be forfeited and other actions may be initiated including blacklisting the Bidder. **H2 in that case the Divisional Level Auction Committee (DLAC) has the right to award the contract to the next H2 Bidder before going for re-auction of the goods at the cost of the defaulter.**

**19. The Auction Committee reserves the right to re-auction the whole / remaining sold out stock which has not been lifted by the successful Bidders after 30 (thirty) days from the issue of the Delivery order.**

**20. Right to reject/ accept:**

- a. Divisional Level Auction Committee, Jammu, reserve the right to accept/ reject any/ all auction without assigning any reason. Chairman Auction Committee also has the right to cancel the auction at any stage/ at any point of time with or without assigning any reason.
- b. Chairman Auction Committee reserves the right to accept or reject any bid including the highest H1 rate without assigning any reason.

**21. Resolution of Disputes:**

- a. In case of disputes, if any, the decision on the matter of dispute by the Divisional Level Auction Committee Directorate of Agriculture & Farmers Welfare, Jammu (UT of JK) shall be the final and binding upon all the participating bidder. It is also provided that the courts at **Jammu District** only will have the jurisdiction to decide the dispute between the Directorate of Agriculture & Farmers Welfare, Jammu and other party in respect of the matter arising out of the contract/ acceptance of order. All transaction bills are subject to Jammu jurisdiction.

**22. Force Majeure:**

- a. The bidders shall not be responsible for failure or delay in performing their obligations under presents due to force majeure, which shall include Natural calamities including epidemic, lightning, earthquake, flood, storm, or other unusual or extreme adverse weather or environmental conditions.
- b. If the circumstances leading to force majeure occur, the affected party shall give notice thereof to the other party i.e. Directorate of Agriculture, Jammu.

- c. The notice shall include full particulars of the nature of Force Majeure event, the effect it is likely to have on the Affected Party's performance of its obligations and the measures which the Affected Party is taking, or proposes to take, to alleviate the impact of the Force Majeure Event and restore the performance of its obligations.
- d. The obligations of the Affected Party shall be suspended to the extent they are affected by the Force Majeure.

**23. Base Price**

The base price for each lot is calculated on basis of recommendations of the Survey and Price Evaluation Committee under the Chairmanship of Joint Director Farms, Spices & Medicinal Plants, procurement Mandies & SLUB, Jammu vide Letter No: **JDSLUB/Dev-09/2025-26/332-38, dated 31-05-2025** constituted for the purpose and is in Detailed Notice Inviting Auction (DNIA), which will be exclusive of applicable GST, IT, SC or any other taxes as per rule.

**24. Transfer / Sublet / Assigning contract to third party**

The successful bidder/buyer shall not sublet, transfer or assign the contract or any part thereof to any third party, without the previous written approval of the Committee.

**25. Other terms and conditions**

- a. The quantity mentioned in the Auction Notice DNIA is as per book balance and is as per "As is, where is" basis.
- b. No other terms and conditions beyond the terms and conditions as stipulated in this auction notice will be entertained.
- c. Conditional offers will be deemed to be invalid and will be rejected outrightly.
- d. No plea citing misunderstanding or ignorance of conditions put forth subsequent to any confirmation of sale shall be accepted.

**26. Indemnity**

The contractor shall make the Departmental harmless and shall settle all compensation claims arising as a result of accidents etc during the execution of the contract at his own cost.

## **Section II**

### **INSTRUCTION TO BIDDERS**

#### **1) Registration & Enrolment of DSC**

- a) The Bidder shall enrol himself / herself in the e-auction portal <https://eauction.gov.in/> and obtain User ID and Password for bidding.
- b) To participate in the e-auction, the bidder shall also have a valid Class 3 Digital Signature certificate (DSC), obtained from either of the certifying authorities, enlisted by **Controller of Certifying Authorities (CCA)** at <http://cca.gov.in>. Existing Class 2 DSC which has already been registered in the auction portal <https://eauction.gov.in/> will remain functional as it is. But any new enrolment of DSC in the auction portal <https://eauction.gov.in/> shall be done with a valid Class 3 Digital Signature certificate (DSC) mandatorily.

#### **2) Firms Eligible to Bid:**

A) The firms / bidders as has been blacklisted or debarred or suspended by the Government for whatever the reason, prohibiting them not to continue in the contracting business shall not allowed to participate.

#### **3) Disqualified / Debarred / Suspended / Blacklisted criteria:**

- a) Furnished false/ fabricated particulars in the forms, statements and / Annexures submitted in proof of the qualification requirements and/or
- b) Not turned up for entering into agreement, when called upon after awarding H1 for the auction.
- c) Record of poor progress such as abandoning the contract, not properly completing the contract, inordinate delays in completion, litigation history or financial failures etc. and/or
- d) Even while execution of the contract, if found that the contract was awarded to the Bidder based on false/ fake certificates of experience, the Bidder will be blacklisted and necessary action will be taken as per rules.

- Auction Start Date & Time and Auction End Date & Time:** - Live auction would be conducted during this period.
- Auction Base Price/ Starting Price:** It is the base price which has been set as the starting price of the e-auction. Bidder will not be allowed to quote the rate less than the base price.
- Incremental Value:** It is the minimum value/ amount an auction bid must be raised each time the current highest bid is surpassed.
- Auction Elapse Time in minutes:** It is the time factor in minute(s) before the 'Auction End Time' and acts as a trigger for auto extension of current auction. If a bid is received successfully within these minutes, the auction will be extended by specified time period.
